As **Co-Director, Center for an Independent and Sustainable Democracy** at Arizona State University, I am responsible for the direction, oversight, and administration of the Center. The Center aims to foster and support thoughtful, innovative research, policy briefs and forums around the state of American Democracy. The two-fold focus is on exploring nonpartisan reforms and redesigns of federal, state, and local governance of electoral structures, and a deep dive examination of the independent voter.

As **Professor**, School of Public Affairs, I am tenured and teach in both the undergraduate and graduate programs with a focus on public sector and nonprofit management , public policy, and human resource management.

As **Chancellor** of the Nevada System of Higher Education (NSHE), I served as chief executive officer and oversaw, under the authority of an elected board of regents, a complex system that included R-1 research universities, four-year undergraduate institutions, a research institute and community colleges. During my tenure, I have accumulated an impressive record on multiple measurable dimensions of success centered on increased accessibility, student success and expanded workforce training and education.

Notable accomplishments during my tenure include:

7) increasing leadership diversity throughout NSHE including the hiring of four Hispanic, an African-American and an Asian Indian President;

8) developing a strategic partnership with K-12 focused on creating stronger and more robust pathways from high school in career and technical education (CTE); and

9) strengthening the transfer and articulation process for students by auditing every single regional transfer agreement, hiring the first statewide Transfer and Articulation

Ombudsperson to assist transfer students with any challenges and establishing the Articulation Coordinating Committee to mediate disagreements between institutions to ensure seamless transfers.

As **Director/Professor** of the Morrison Institute for Public Policy (a non-partisan policy think tank), I was responsible for the direction, oversight and administration of the Institute including securing funding and contracts to ensure its successful operation; identifying key

policy areas; building relationships with governmental officials; non-profits and business leaders; identifying areas for regional research and impact; and development key metrics to measure outcomes. In addition to the following strategic policy areas: education, water, governance, immigration, human services, demographics and the economy; the Institute included two Centers: The Kyl Center for Water Policy and the Latino Public Policy Center.
